

#### **1.- BACKGROUND**

The Congress is the last great activity of the four-year World Campaign on the Human Right to Peace (2007-2010) carried out by the **Spanish Society for the International Human Right to Peace** (SSIHRL), in collaboration with more than 800 NGOs from all over the world. The Campaign was designed to achieve three main objectives, namely:

Firstly, to disseminate and share the *Luarca Declaration on the Human Right to Peace* of 30 October 2006 with experts from civil society world-wide. Since the adoption of the *Luarca Declaration*, 20 regional expert meetings have been convened in the world and seven regional Declarations of adhesion to the international codification process on the human right to peace have been adopted<sup>1</sup>.

Secondly, to include the human right to peace into the agenda of the Human Rights Council and its Advisory Committee. On 17 June 2010, the Human Rights Council initiated the official codification by explicitly recognizing the important work being carried out by civil society organizations in the codification of the right to peace and requesting the Advisory Committee to prepare a *draft declaration on the right of peoples to peace*<sup>2</sup>. In addition, the Advisory Committee established on 6 August 2010 a *drafting group* of four members with the mandate to prepare by January 2011 a draft declaration<sup>3</sup>. And

Thirdly, to conclude in December 2010 the international civil society codification of the human right to peace, through the adoption of a draft universal declaration which will take into account all inputs received from the different perspectives existing in various parts of the world.

Taking into account that the two first objectives have been successfully achieved, the Congress is organised to reach the third one. To this purpose, the SSIHRL in collaboration with the Forum 2010, the World Council of Churches (Geneva, Switzerland) and the Institute for Peace Studies (Alexandria, Egypt), as well as the sponsorship of numerous institutions, will organize in *Santiago de Compostela* (Spain) on 9-10 December 2010 the **International Congress on the Human Right to Peace**,<sup>4</sup> in which the international civil society will be invited to achieve two main objectives:

Firstly, of a normative nature: to definitively approve the **draft universal declaration on the human right to peace.** To achieve this objective, participants will have before them Declarations already adopted by experts along with the World Campaign, namely: the *Luarca Declaration on the Human Right to Peace* of 30 October 2006; the *Bilbao Declaration on the Human Right to Peace* of 24 February 2010; and the *Barcelona Declaration on the Human Right to Peace*, adopted on 2 June 2010 by the International Drafting Committee<sup>5</sup>.

The Santiago Declaration on the Human Right to Peace, expected to be adopted on 10

December 2010, will be brought to the attention of the Human Rights Council and its Advisory Committee as a final contribution from the international civil society to the international codification process of the right to peace. The United Nations and its member States and experts will have before them a solid text, which should be the basis of the official codification of the right to peace.

Secondly, of an institutional nature: to debate and eventually establish an **International Observatory of the Human Right to Peace** integrated in the SSIHRL to, *inter alia*, promote and implement the *Santiago Declaration on the Human Right to Peace* world-wide. It will also ensure that the current process of international codification of the right to peace takes into account the *Santiago Declaration* and comes to a successful conclusion by the UN General Assembly.

#### **2.- METHODOLOGY OF THE CONGRESS**

*The International Congress on the Human Right to Peace* will take place on 9 and 10 December 2010. It will be composed of three full working sessions and two commissions. Each session will last three hours (morning and afternoon). The program will also include an opening and a closing session. In addition, on 10 December 2010 the program will start with the solemn commemoration of the International Day of Human Rights.

Each working session, the opening and closing sessions, and the commemoration of the International Day of Human Rights, will be chaired by different personalities. Both Commissions will have their respective chairperson and rapporteur. A limited number of commentators will complete the essential content of the Congress.

In addition, participants will have the opportunity to take part at the discussions at the end of each session.
